D) Other items for Discussion(s): New Business:

- 1) Seller server program.
- 2) Restaurants in ratio area. Chairman Franklin feels that some restaurants are not acting like restaurants but are instead acting like bars.
- 3) Discuss Board policy on renewal of managers/assistant managers ABC cards when they expire. The chairman would like to have the Board have ALL Managers/ Assistant Managers have their names come before the board every year with updated clearances. This will be discussed more on the next board meeting.
- 4) Board policy regarding strippers as employees of the strip club. Are they considered employees even if they are not a permanent employee but under a contract agreement? Still discussing.
- 5) Clarification on what time last alcoholic drink can be "sold" and what time must all alcohol be finished being consumed? Can customer stay in club up to 3:00 AM drinking water/eating? The board has voted that EVERYONE (Including staff) has to exit by 3am.
- 6) Clarification of "posting drink prices" requirement. Must drink prices be posted on the club wall; any font size requirement (e.g., must be able to be read by the customers). The board has voted that yes, a listing of drink prices has to be present either on the wall or on a menu.
- 7) If the owner is the "manager on duty" and does not have an ABC card, can the owner mix/serve alcohol? There was a lot of discussion on this. The ABC compliance team states that the license that has the owners name is the ABC license. More discussion on this issue.
- 8) Conditional Approval(s) - Once all the conditions of a conditional approval have been met, the entire package will be made available at the next scheduled Board meeting for examination. The ABC compliance team stated that this can be accomplished and they will be providing the applications that were conditionally approved to the Board for review when the applicant's packet is complete.
- 9) Revocation of Orren Longs ABC Managers Card. The board determined that he cannot be the Manager on duty for multiple locations at the same time and still be in compliance with the law regarding a manager or owner on duty in the premises. The applicant will also have to pay for the multiple licenses.
