 - O New restaurant owner does not wish to serve alcohol but use the alcohol to cook food. Owner request letter addressed to wholesaler that the board approve the wholesaler be able to sell to restaurant owner without alcohol license.
- Chairman Llaneta joins meeting. Co-Chairwoman provides summary of meeting.
 - Chairman Llaneta disagrees the conditional approval of Kitchen Lingo's Manufacturer's License.
 - o Cites 11 GCA Chapter 3 says that brandy or whiskey or every product of distillation of any fermented liquid which is fit for distilled spirits. Chairman Llaneta stated that Kitchen Lingo are mixologists and not manufacturers.
 - o No businesses authorized to manufacture alcohol besides breweries. Cites Title 11 Annotated Chapter 3.
 - o Chairman Llaneta states that the board has made a mistake on approving this license.
 - o Ms. Fisher stated that the interpretation of what a manufacturer is are different.
 - o Chairman Llaneta will write up a rebuttal to the conditional approval of Kitchen Lingo's license.
