A) Bill 16-36

- a. Reviewed and discussed letter written by Chairwoman Fisher to be sent as testimony for Bill 16-36.
- b. Discussed decisions made by the board in the past year to assist businesses on Guam throughout the pandemic.
- c. Discussed all sections that the bill calls to amend and repeal.
  - i. Section 3123 – Supervisor Camacho provided insight on the amendment on this section for third party delivery drivers.
    1. Unable to enforce law on companies without ABC license. Laws are written to penalize ABC license holder.
    2. Recommend adding class of ABC license for third party delivery drivers.
  - ii. Section 3300 – Removal of the verbiage Beer on section
    1. Supervisor Camacho provided insight on meaning of the removal of beer for this section.
    2. ABC Board on board with change.
  - iii. Section 3413 – No issue with amendment on this section.
  - iv. Section 3414 – No issue with amendment on this section.
  - v. Section 3433 – No issue with amendment and repeal of language on this section.
  - vi. Section 3218 – Chairwoman Fisher provided possible terms and restrictions to add/remove in section.
    1. Jurisdiction ends at point of sale. No regulation would be too strict.
  - vii. Section 3428 – Chairwoman Fisher not on board with the removal the section regarding stacking.
    1. To remove Section 3432, they will need to remove this section.
    2. Board member Ilaio is on board with repealing this section.
    3. Supervisor Camacho reminds board the responsibility falls on the licensee.
    4. Board member Okuhama is for removing the stacking law.
- d. Chairwoman Fisher discusses stiffer penalties to licensees for the violation of law.
