## 2. Request to Petition the ABC Board - Rodney Webb

- Chairwoman Fisher summarized all documents including invoices, court documents, etc.
- Chairwoman Fisher wanted to question Mr. Webb why he is appealing if the court has reached a decision and if the board has the right to override the dismissal of the courts decision.
- Supervisor Camacho stated that based on statue, any taxpayer has the right to petition the board.
- Case dismissed and court authorizes to destroy the products.
- Chairwoman Fisher questioned why it's taking long to destroy products.
- Supervisor Camacho stated that Mr. Webb provided the court order to destroy products.
- The compliance branch receives a destroy order from Attorney General's office but have not received it yet.
- Chairwoman Fisher requested the Compliance branch to inform the board what our rights or authority the board has to override the dismissal.

• Supervisor Camacho will reach out to legal team for guidance on Board's rights.
