- it is the responsibility of the Compliance Branch to review complete application packages and recommend approval to the Board;
- Titay's Ent.'s application package was complete (contained a lease agreement and business license), and;
- the Owner's terminated the lease with the Lee's and signed a new agreement with the new applicants (Titay's Ent.).

The Board agreed that in addition to complete and/or compliant applications, applicants should also adhere to basic ethical standards.




