- Call to Order: Meeting was called to order by Acting Chair Okuhama at 4:02 PM.
- II. Roll Call: Present in person were Acting Chair Okuhama, and the Compliance Branch Staff. Present via Zoom were Board Members, Pangelinan, and Toves. Deputy Director Maria Lizama was present via Zoom.

A) Meeting Minutes - December 9th, 2021

Mr. Pangelinan moved to approve the previous meeting minutes. Motion seconded by Mr. Toves, and approved without dissent.

B) RR Enterprises, LLC Dba: Horse and Cow Pub & Grill (*Takeover*) - Tabled from last meeting 12/09/2021.

Mr. Rupley attended the meeting, and there was continued discussion over his criminal record, and how it could affect the takeover. Deputy Director Lizama addresses Mr Rupley, and asked how his establishments record compares to other similar establishments. Mr Rupley does not answer Deputy Director Lizama's question, and instead states that he has been sober for a number of years, and that he is currently a mentor for people affected by addiction. Mr. Camacho advised that conditional approval could be given based on a clear record, for an established amount of time.

Mr. Pangelinan moved to Deny the application based on the applicant's criminal record, and recent run-ins with the law, which are in direct violation of ethical standards the board feels are required to operate an establishment that sells Alcohol. Before the motion carries, there is discussion with Mr Rupley, and he asked if we would reconsider his application after a year. Mr. Pangelinan replies yes, that the board would be open to reconsider the application.

Mr. Toves asked if he can say what his motion would have been although he did not vote. Mr. Camacho advised he can, and he stated he would have voted against the motion to deny the applicant on the basis of providing a second chance to the applicant.

DRT Staff identify that since Ms. Okuhama is acting Chair, she is unable to second a motion, so Mr. Camacho advises that the motion made by Mr. Pangelinan does not carry.
