Chairwoman Fisher wanted validation that the IMF event was conditionally approved pending plan of wristbands to differentiate between minors and adults as well as plans on who was going to hold the applicant accountable. Board members and compliance team confirmed that this was all discussed.

Chairwoman Fisher received feedback from her daughter, 17 years old, who attended the event. Wristbands that were provided were based on level (General Admission, VIP, Etc.) and by day. There were more servers than originally listed and no distinction between minors and adults. Pangelinan added that there was no ID check.

Supervisor Camacho noted that the applicant provided through email that they were going to utilize red Budweiser wristbands. He added that, he had staff attend, at an unofficial capacity and noted that in the beginning, the event was doing ID check and wristbands. However, as things escalated, they observed stopped. Compliance team issued license because applicant was able to meet the condition in writing.

Camacho did submit an overtime plan that will be presented in the next agenda for approval. Once approved, the compliance team will have more presence in an official capacity.

Fisher added that there was more servers than what was listed on the application, and noted that the Inalahan event, stating that she did not one event to ruin it for the rest. Camacho confirmed that the event had additional staff to assist in putting together the order, for the licensed server to provide to the customer. Camacho added that his team is working on improving the application process as these are getting bigger.

Camacho noted that his team is working with promoters and applicants in reminding them part of the security detail is responsible in enforcing the alcohol laws.

Pangelinan asked what happens to applicants for violating the law. Camacho responded that the board can issue a penalty. However, once his team can be there at an official capacity, his team will be able to provide a write up to the board to decide on the violation. He added that if board members were present at the event, and witnessed the violation, then those board members will not be able to vote. It presents a conflict.

Glenn Meno added that we, the board and compliance branch should also be concerned with the government's liability exposure that may come if alcohol were to get in the hands of minors on public land. Camacho added that the applicant will be held liable for any violations.


