- I. Call to Order: Meeting was called to order by Chair Fisher at 4:02 PM.
- II. Chair Fisher addressed the AG's opinion dated August 2013, citing Section 35-16 of the GCA, stating that a majority of all members (5) of the board constitutes a quorum. It was therefore acknowledged that three members constituted a quorum, no objections.
- III. Roll Call: Present in person was Vice Chair Okuhama and Compliance staff. Attending via Zoom were Board Members John Ilao and Chair Fisher. 5. ABC-2023-005 TGBTH2, LLC. DBA: TGBTH2 ABL # 15124
Bartender with valid ABC card, however no manager on duty. Unable to get ahold of licensee, they shut down operations for the evening. Licensee acknowledged and agreed to the \$1500 fine for first offense violation. Licensee wrote a letter to the Board requesting to pardon the licensee for the fine. Board agreed not to pardon the fine.

7. ABC-2023-007 D.T. Potter Entertainment Inc. DBA: Toy's Tavern ABL # 14877
Multiple complaints about the establishment staying open after legal operating hours. Compliance Inspectors were able to gather enough evidence on the establishment in addition to the incidents reported by the Guam Police Department (GPD). The Administrator on behalf of the Compliance Branch issued a 48-hour suspension and the matter was brought to the Board for discussion and final disposition.

Mr. Potter admitted to the Board that he understood that the violations were pretty gross and did not dispute the allegations. He advised that he has been closing at 2:00AM and that these infractions would not happen again if he is able to keep his license. He agreed to pay any amount of penalty without dispute.

Chair Fisher reminded Mr. Potter is running an establishment that sells alcohol and alcohol affects a community, hence why the laws are very strict. She summarized the findings of GPD and the Compliance branch, and stated that having patrons park in the adjacent lot to the bar's parking lot is intentional. Furthermore, Mr. Potter is also a member of the US military where people are held to higher standards. It is disappointing that additional resources were used to regulate and discipline his business. Chair Fisher confirmed that she was inclined to go with the full suspension of 90 days.

Mr. Potter responded that he understood her position, but asked for a more lenient penalty. He stated that he is in debt and trying to recover, which is the reason why remained open after the legal operating hours. Mr. Potter also requested for one month's suspension, but understood if the Board decided otherwise.

Mr. Ilaó referenced Mr. Camacho's report stating that they received multiple complaints regarding the establishment being open after hours. He stated that a license is given to a responsible citizen and the licensee has not shown that responsibility. He expressed the same sentiment as Chair Fisher and added that revoking his license is an option.

Ms. Okuhama added that as an operator, Mr. Potter is expected to comply with ABC regulations, and given the multiple violations, Ms. Okuhama agreed with a 90-day suspension.

Mr. Camacho added that the discussion of the suspension and revocation is on top of the monetary fine.

Chair Fisher did not believe that the Board has reached the point of revoking his license. She expressed her understanding the licensee's financial situation, but failure to follow the law does not help given the consequences he now has to face. The \$1500 fine and 90-day suspension were recommended.

Ms. Okuhama moved to impose a 90-day suspension and approve the violation, acknowledged the \$1500 fine, the first offense and reports provided to the board. Motion seconded by Mr. Ilaó and approved without dissent.

Supervisor Craig noted that he will dispatch a team to issue notice of suspension today, to inventory the alcohol, remove from the premises, and place in the custody of the Compliance branch.

8. ABC-2023-008 Navarrete, Ronnie N. DBA: Mile High Club (Not licensed)
Operating without valid business and alcohol licenses. Claiming alcohol was purchased from Cost-U-Less and Payless and was not working with any of the wholesalers. The establishment had been operating under these conditions for about a month.

Ms. Okuhama moved to approve violation, acknowledged the \$1500 fine and the first offense. Motion Seconded by Mr. Ilaó and approved without dissent.

Two cashiers without valid ABC cards on duty. Manager for the district came on-site. Unfortunately, he is only an employee and the license holder is responsible. SPPC has their own training program for ABC card holders.
