Tenant shall pay the following rent to Landlord for the term of this agreement on or before the fifth day (5th) of each calendar month without any deduction, set-off, prior notice or demand:

- A. \$6,600 (SIX THOUSAND SIX HUNDRED DOLLARS) per month for the period commencing 01 JULY 2024 and ending 30 JUNE 2026.
- B. \$6,930 (SIX THOUSAND NINE HUNDRED THIRTY DOLLARS) per month for the period commencing 01 JULY 2026 and ending 30 JUNE 2027.
- C. Rent shall continue on a month to month basis with the most recent rent thereafter until a new lease or extension is signed.
- D. Rent is payable in advance on the 5st day of each calendar month, and is delinquent the next day.
- E. A late fee of 5% of monthly rent may be charged to Tenant.

4. OTHER:

The aforementioned lease agreement is amended as follows:

A. Tenant is granted an option to extend the term of the Lease Agreement for one (1) additional three (3) year period. The extensions described in this Addendum are personal to Tenant and may not be assigned, voluntarily or involuntarily, separate from or as part of the Lease. Such extension shall be on the same terms and conditions as provided in the Lease Agreement and this Addendum with the exception of Base Monthly Rent, which will be determined


