Mr. Camacho notified the Board that a new applicant, applicant #11, received a first offense DUI infraction in July 2023. He was sentenced to one year at the Department of Corrections, with a condition prohibiting the consumption of alcohol or drugs, as well as entry into establishments primarily engaged in the sale of alcoholic beverages. The applicant is required to furnish the compliance staff with the status of his probation. The compliance team recommended postponing a decision on the applicant until he can provide an update.

With the exception of applicant #11, Ms. Okuhama moved to blanket approve. Motion seconded by Mr. Ilao and approved without dissent.

VIII. Other Discussion:

Chair Fisher inquired of the Compliance branch and the Board regarding the measures being taken to address the issue of alcohol sales to minors, particularly concerning seltzers that do not fall within the classification of beer and wine. Mr. Camacho verified that the compliance team actively monitors areas with a high incidence of underage alcohol consumption. Previous investigations with the Guam Police Department's Juvenile Investigation Section uncovered a loophole where adults can legally purchase alcohol from licensed establishments, but supervision is lacking once the alcohol reaches their homes. Additionally, instances have arisen where minors are found in possession of alcohol but refuse to disclose the identity of the individual who procured it for them. Mr. Camacho indicated that the Compliance team maintains a strong partnership with the Juvenile Investigation Section and, if necessary, any related cases will be brought before the Board. Chair Fisher inquired about potential preventative measures, proposing the installation of alcohol restriction signs with standardized messaging to enhance consumer awareness. Mr. Camacho mentioned the absence of such signs but expressed readiness to collaborate with the legal team on drafting appropriate verbiage and utilizing the alcohol enforcement fund to acquire the signage.

Chair Fisher sought information on addressing Ready to Drink (RTD) and seltzer options that do not align with the beer or wine categorization. Mr. Camacho referenced an instance where an applicant was licensed solely for beer and wine but was found to stock Soju and RTDs during an inspection. After seeking legal counsel, it was determined that, based on their production method, these beverages could potentially be classified as beer. Efforts have been made to engage wholesalers, educating them on the permissible beverages for sale by various license holders.

Mr. Camacho detailed the team's preparations to resume inspections, underscoring the volume of manager and assistant manager applications received and the successful enforcement actions taken, including two suspensions conducted the previous year, showcasing the Compliance branch's vigilance.

Chair Fisher raised concerns regarding Senator Quinata's bill proposing an extension of drinking hours until 4:00 AM, expressing apprehension about potential compliance breaches resulting from the extended timeframe.

Chair Fisher also inquired about a whistleblower case related to unpaid taxes that emerged during her confirmation hearing and its relevance to the ABC Board. Mr. Camacho affirmed the Board's responsibility for overseeing licenses and determining whether licensees should be permitted to continue operations. During the renewal process, licensees must obtain clearance from relevant government agencies. The compliance team has accepted applications for renewal, with cases unable to be renewed being escalated to the Board for resolution.

Chair Fisher addressed inquiries concerning potential conflicts of interest arising from her role at the Department of Administration. She emphasized her commitment to compliance and welcomed any identification of conflicts to ensure adherence to regulations. Mr. Camacho highlighted the meticulous review process for appointments originating from the Governor's office, where a legal team scrutinizes appointments and recommendations before submission for consideration.

Lastly, Chair Fisher sought clarification on appointment dates. Mr. Camacho clarified that appointments expire 90 days post-appointment, with allowances for an additional three legislative days. While acknowledging the lapse beyond the 90-day threshold, he confirmed compliance with the stipulated provisions.
