

Subject: ABC Regular Meeting – February 19, 2025 (Final)

I. Continuation of Meeting – February 20, 2025 at 4:00 PM.

Ms. Fisher inquired whether the applicant holds a valid Class 5 off-sale license. Mr. Camacho confirmed that they do. She then asked how the applicant intends to provide annual documentation to the Board demonstrating that at least 80% of product sales are derived from off-premise transactions. Mr. Camacho explained that it is the applicant's responsibility to compile and submit this data. He added that the Compliance Team will work closely with the applicant, as this is a new process for all parties. Provided the applicant notifies the Compliance Team of scheduled events, posts clear "consumption only" signage, and limits tastings to a maximum of three 3-ounce servings of wine or beer per customer per day, they will be considered in compliance.

Ms. Fisher further asked whether the Compliance Team would notify the applicant when the report is due. Mr. Camacho confirmed that the team will flag the applicant accordingly. He also noted that the required signage was prominently displayed and that the applicant is willing to make any necessary corrections.

Ms. Fisher then raised a question regarding potential inconsistencies between Sections 6 and 14. She observed that Section 6 allows the sale of up to 9 ounces of wine or beer per customer per day, while Section 14 permits up to 3 or 6 servings—totaling 18 ounces. Mr. Camacho clarified that Sections 6 through 8 apply to tastings conducted during regular business hours, whereas Section 14 pertains to private tasting events held outside of normal hours with a maximum of 40 attendees.

Mr. Artero elaborated that Section 14 permits corporations or individuals to host private functions and that the stricter limitations in Section 6 are intended to prevent tasting rooms from functioning as de facto bars or restaurants.

Ms. Fisher also cited additional provisions, such as limiting the tasting area to no more than 30% of the business's leasable space. Mr. Camacho confirmed that this requirement was identified in the applicant's packet. She also mentioned the stipulation that alcohol must be delivered or picked up at a later date, which Mr. Artero affirmed as well.

**Mr. Camacho stated that the Compliance Branch recommended tabling the application until the Board could familiarize itself with the requirements of a Class 14 license. Ms. Fisher asked if this is a tasting license. Mr. Camacho affirmed and provided the location. He also noted that the applicant currently held a Class 5 off-sale license, which does not permit on-premise consumption. In contrast to a special display and tasting license, a Class 14 license allows tastings under specific regulations and within designated areas of the facility.**

**Mr. Ilao moved to table. Motion seconded by Ms. Okuhama and approved without dissent.**

**Mr. Ilao expressed concern regarding the limited number of vendors, noting that only seven servers were listed, and emphasized the timing of the event. Ms. Fisher inquired whether the Council typically holds its events for the full duration indicated. In response, Diana from the Umatac Mayor's Office confirmed that the event traditionally spans two consecutive weekends. She also noted that alcohol sales are minimal during the early hours, with the majority of sales occurring in the evening.**

**5. Pacific War Museum DBA: Same.** A Class (10) General On-Sale, Temporary Alcoholic Beverage License application For the "Common Kings Live in Guam" Event to be held at Gov. Joseph Flores Beach (Ypao Beach Park) on Saturday, March 29, 2025 from 3:00pm to 12:30am.

**Ms. Fisher expressed concerns regarding inadequate alcohol control at recent events, citing feedback from the public and referencing a concert held at Leo Palace the previous month where alcohol was reportedly distributed without oversight. She emphasized the importance of accountability in event plans and questioned whether vendors are fulfilling their responsibilities in regulating alcohol distribution and consumption.**

**Mr. Camacho recommended tabling the discussion until the applicant could join the Zoom meeting.**

**Upon the applicant's arrival, Ms. Fisher reiterated her concerns and asked how the applicant planned to manage alcohol sales at the upcoming event. Ms. Kim Gogue acknowledged the concerns, referencing the Kolohe Kai concert as the basis. She outlined several corrective measures, including a separate admission line for attendees aged 21 and over, and the use of security personnel to monitor the crowd and ensure only attendees with wristbands consume alcohol. Bartenders will also be instructed to verify wristbands before serving.**

**When asked by Ms. Fisher about the distribution of wristbands at previous events, Ms. Gogue explained that while wristbands were initially issued at the main entrance, long lines led to a shift in distribution to the bar area. Nonetheless, staff continued to monitor for wristbands throughout the venue. Ms. Fisher asked whether alcohol had been handed out freely at prior events. Ms. Gogue firmly responded that such practices are not permitted and should not occur.**

**Regarding the event schedule, Ms. Fisher inquired about the performance time for Common Kings. Ms. Gogue noted that the opening act would be starting at 4:30 PM and doors opening at 3:00 PM. Common Kings is expected to start at 8:30 PM and the concert is expected to conclude around 10:00 PM, but may extend to 10:30 or 11:00 PM.**

**Mr. Ilao stated he had no objections to the event timing but emphasized the importance of executing the approved event plan. He acknowledged the challenges of managing large events and reminded the applicant that adherence to the plan is critical.**

Ms. Fisher recommended adjusting the event timeframe to 4:00 PM to 11:30 PM to allow for flexibility and better crowd management. Mr. Ilao supported the extension, noting that it would help ensure compliance with alcohol regulations and smooth event closure. Ms. Okuhama agreed with the recommendation and thanked the applicant for attending and providing clarity.

Mr. Ilao moved to approve the event with the updated timeframe. The motion was seconded by Ms. Okuhama and passed without objection.

The UMPC has almost annually hosts the Guam History & CHamoru Heritage Day Festival which is a 4-day event and we are familiar with the Department of Revenue & Taxation's requirements for the sale of alcohol products at these type of community events. It is our intent to have 4-6 individuals with ABC licenses to man the alcohol booth.

We have submitted all required documentation and are hopeful that the ABC Board will approve our Temporary Alcohol License for this event.
