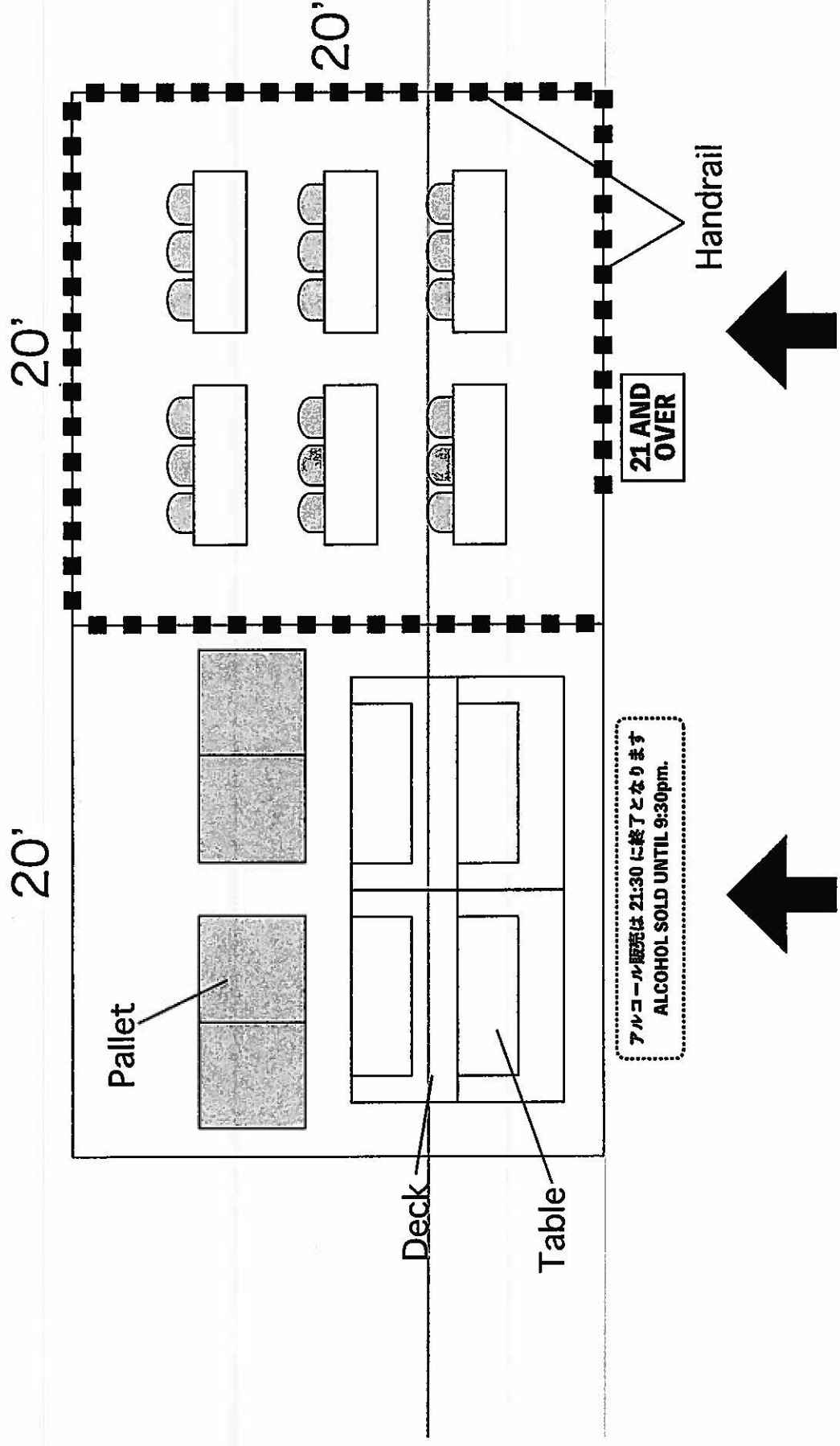

Plans to Distinguish Minors from Adults

The Japan Club of Guam is committed to ensuring the responsible service of alcohol and strictly preventing minors from accessing alcoholic beverages during the 43rd Guam Japan Festival (Harumatsuri).

To enforce this policy, we will implement multiple measures to ensure compliance with the legal drinking age.

To distinguish eligible guests, we have prepared 2,000 wristbands, which will be required for purchasing alcoholic drinks and entering designated drinking areas. ID checks will be conducted at the drink sales booths, and wristbands will only be issued to eligible individuals. This requirement will be announced during the ticket pre-sale period and at the ticket booth on the event day. Additionally, the MC will make periodic announcements to reinforce this rule.

Clear signage stating "**No alcohol under 21**" will be posted at the ticket booth, drink sales booths, and drinking tents to remind attendees of the age restriction.

To further ensure compliance, only adults wearing the designated wristbands will be allowed to purchase alcoholic beverages and consume them inside the drinking tents.

Through these measures, the Japan Club of Guam is making every effort to enforce the legal drinking age responsibly.

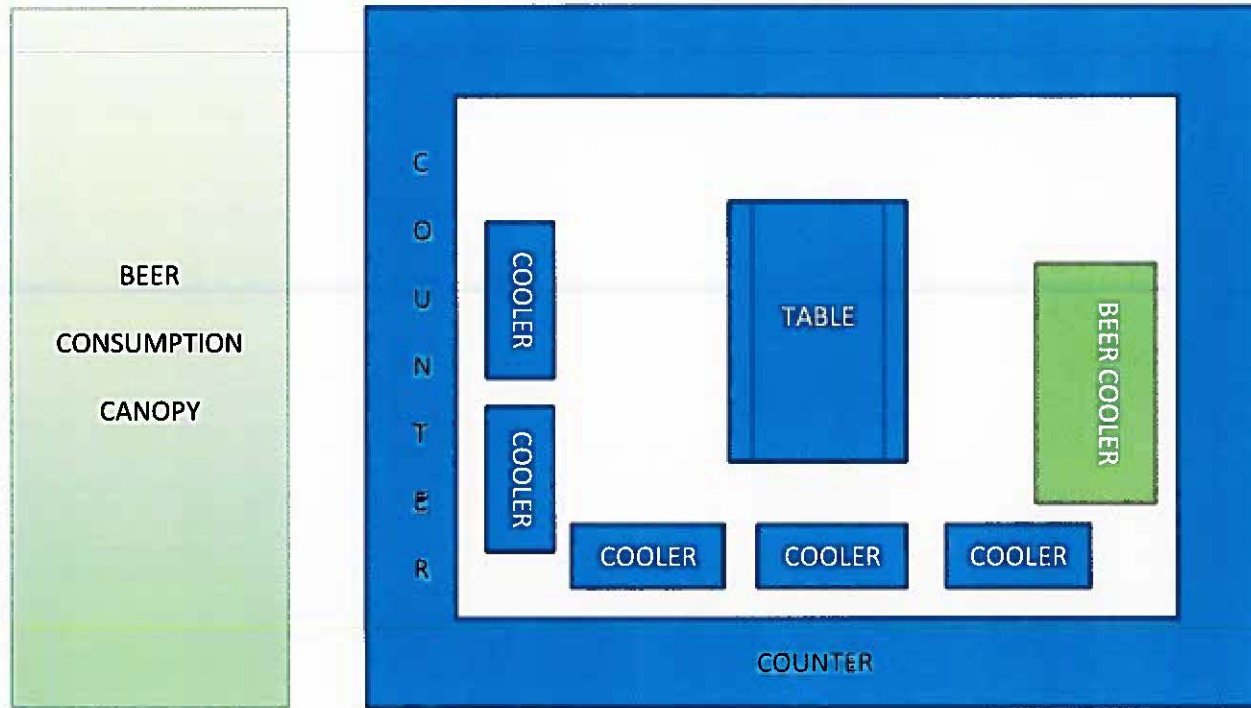

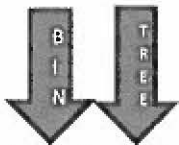

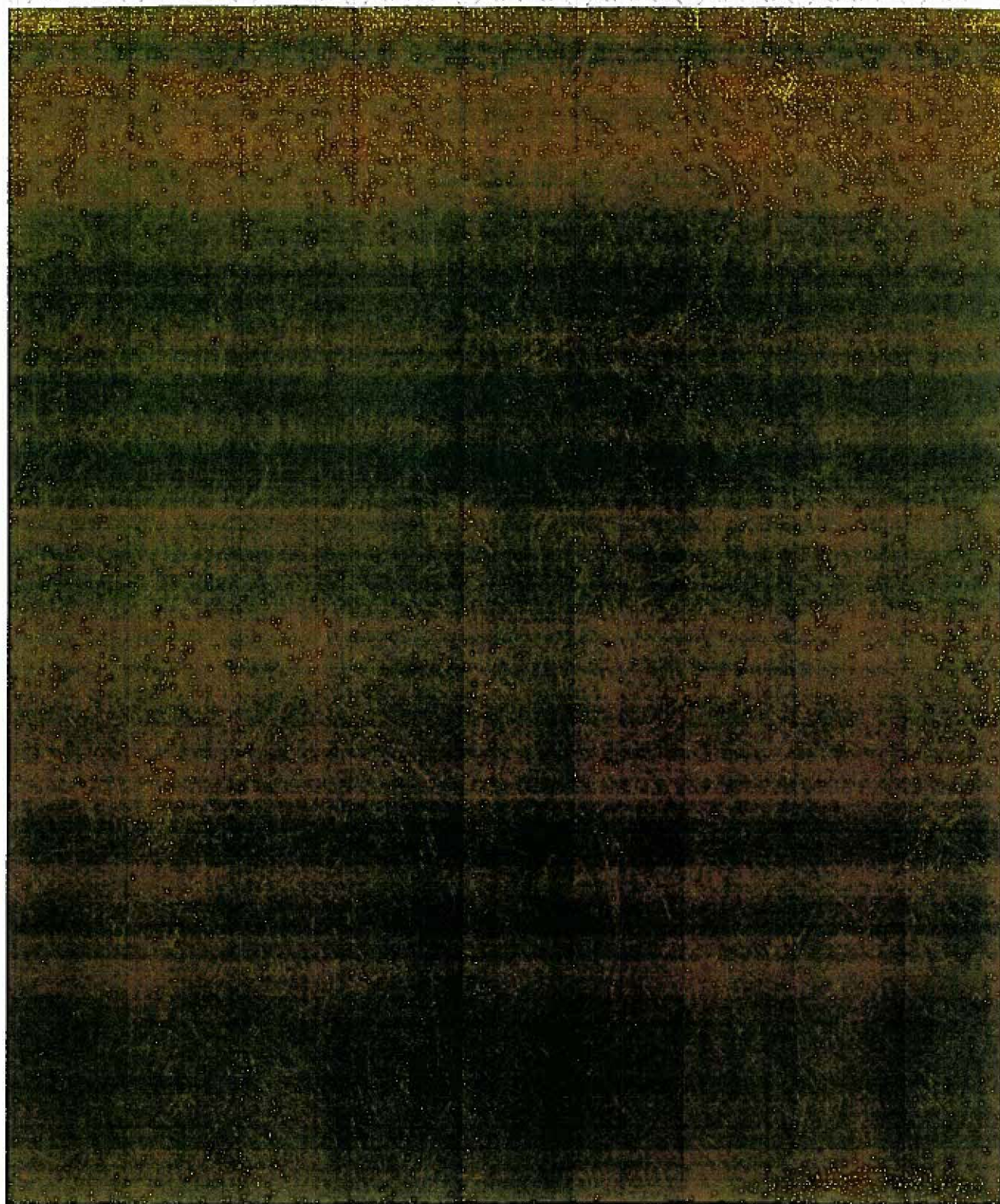
