SOP for Distinguishing Adults from Minors at THE FALL FARMERS MARKET

Objective:

To ensure compliance with alcohol licensing regulations, all adults consuming or purchasing alcohol must be verified as being of legal drinking age. This SOP outlines the procedures for distinguishing adults from minors at the event.

1. ID Check at Entrance to Alcohol Service Area

- All individuals entering the designated alcohol service area must present a valid, government-issued ID to confirm they are of legal drinking age.
- Accepted forms of ID include:
 - Driver's license
 - Passport
 - State-issued identification card
 - Military ID
- IDs will be checked at a controlled access point by security personnel trained to identify valid forms of identification.

2. Age Verification Stamp/Wristband

- Upon verification of age, individuals will receive a clearly visible wristband indicating that they are allowed to purchase and consume alcohol.
 - **Wristband Design:** The wristband will have a unique design that cannot be easily replicated, ensuring that only those who have passed the ID check have access to alcohol.
 - Minors and individuals without proper identification will not receive a wristband or stamp and will not be permitted to enter the alcohol service area.

3. Monitoring Alcohol Consumption

- Security personnel stationed at the entrance and within the alcohol service area will monitor for:
 - Individuals without wristbands attempting to purchase or consume alcohol. ◦ Wristbands being transferred to other individuals.
 - Any signs of underage individuals attempting to drink alcohol or enter the area. •
- Security will immediately remove any individual found violating these rules from the designated alcohol area.

4. Vendor Responsibility

- Vendors serving alcohol will be trained to only serve individuals wearing the official event wristband or stamp.
- Vendors will be instructed to double-check wristbands if there is any doubt regarding an

individual's age.

5. Handling Minors

- Any minors found attempting to enter the alcohol service area or found consuming alcohol will be escorted out of the area by security personnel.
- Any incidents involving minors will be documented, and the individual may be asked to leave the event entirely, depending on the severity of the situation.

Alcohol Service Area: Under a 20X30 canopy, we will create an aesthetic bar that matches our fall theme that will block the access of coolers and beverages. This designated area will be where participants go to purchase alcoholic beverages. Each customer will be asked to present an ID, ensuring they are the age of 21 or over. A wristband issued by our service members will be the indicator of all legal consumption of alcohol.

1. Event Overview

The Farmers' Market will host a range of vendors, including those selling local produce, artisanal goods, and beverages. Alcohol will be served in a designated area in compliance with the temporary alcohol license requirements.

2. Objectives

The security plan aims to ensure the safety of all attendees, staff, and vendors while adhering to local laws and regulations regarding alcohol consumption. Specific objectives include:

- A. Monitoring entry and exit points to prevent unauthorized access.
- B. Ensuring that alcohol is only served and consumed within the designated area.
- C. Managing crowd control to prevent overcrowding and maintain a safe environment.
- D. Responding promptly to any disturbances or emergencies.

3. Security Personnel

A professional security team will be employed to monitor the event and ensure compliance with local laws, specifically those related to alcohol consumption. The team will be responsible for monitoring entrances and exits, managing the flow of attendees, and handling any incidents that may arise.

4. Entrance and Exit Control

There will be one main entrance and exit point to the event, and these will be closely monitored to control access.

Personnel at Entrances and Exits

- **Number of Security Staff:** 2
- **Staffing Hours:** 1-8pm

- Duties:

1. Verify age and identification of individuals entering the alcohol service area by checking their ID and/or wristbands.
2. Ensure that no alcohol leaves the designated consumption area.
3. Monitor the number of people entering the event to avoid overcrowding.
4. Ensure that any restricted items, such as outside alcohol, are not brought into the event.
5. Direct attendees toward emergency exits if needed.

5. Crowd Control

Security personnel will be assigned to manage the crowd in various areas, including the main vendor area and the alcohol service area. The goal is to prevent overcrowding and ensure that all attendees have a clear path to emergency exits.

- Crowd Control Personnel

- Number of Security Staff:** 4 (2 assigned to general vendor area, 2 assigned to alcohol service area)

- Duties:

1. Monitor crowd density and direct attendees to less congested areas if necessary.
2. Ensure that all attendees are compliant with alcohol consumption regulations.
3. Prevent individuals from consuming alcohol outside the designated area.
4. Monitor behavior and handle any disturbances or conflicts.

6. Emergency Procedures

All security personnel will be trained in emergency response procedures, including crowd evacuation, first aid, and conflict resolution. Emergency exits will be clearly marked, and a designated area for emergency services will be established.

7. Incident Reporting

All security personnel will be equipped with communication devices to report any incidents to the security supervisor immediately. A detailed incident report will be filed for any significant issues that arise, including but not limited to:

- Disturbances or conflicts between attendees.
- Violations of alcohol regulations.
- Medical emergencies.
- Property damage or theft.

8. Vendor Security

Vendors will be briefed on security protocols and will have access to security personnel in case of any issues. Vendors will also be advised to keep personal and business belongings secure at all times.

9. End of Event Procedures

At the end of the event, security personnel will ensure that all attendees have vacated the premises safely and that no alcohol is being consumed outside the designated area. The security team will conduct a final sweep of the event space to ensure no security or safety concerns remain.
