A. Alcoholic Beverage License Applications

#### D. Complaint

Berman O'Connor and Mann representing UNK Wholesaler filed a complaint about illegal Jinro being imported by San Jose Market without a license and without proper labeling.

Two ABC Compliance Inspectors visited San Jose Market and were able to determine from invoices that the Jinro in question had been purchased from Hong Liquor, a properly licensed Guam wholesaler of alcoholic beverages.

Further the Jinro in question had proper labeling for the American market.

The ABC Board unanimously agreed that the Jinro was being properly purchased from a wholesaler and was properly labeled. As such there was no violation of Guam Liquor Law and the complaint was without merit. Notice of the resolution of the complaint will be forwarded to Berman, O'Connor and Mann.

Regarding the complaint about the use of Stevioside in the Jinro, the ABC Board has no jurisdiction over this product and referred Berman, O'Connor and Mann to the Health Department.
