VEHICLE LIABILITY INSURANCE - AUTOMOBILE ASSIGNED RISK PLAN

[Title 16 GCA Vehicles, Chapter 23: Assigned Risk Plans]

IMPORTANT: ENSURE ALL DOCUMENTS AND COPIES, AS SPECIFIED BELOW, ARE COMPLETE PRIOR TO COMING TO OUR BRANCH, OTHERWISE WE WILL BE UNABLE TO ASSIST YOU.

PURCHASING / OWNERSHIP TRANSFERRING OF VEHICLE(S):

Effective 11/18/2024, liability insurance will NOT be assigned to licensed driver(s) not registered on the vehicle registration(s). If you purchased or are transferring ownership of vehicle(s), you MUST first proceed to Vehicle Registration Branch located in the Department of Public Works to register the vehicle(s) in your name(s).

If registered owner is unable to drive due to medical reasons or owns the vehicle via a bank loan and has no valid driver's license, the registered owner may designate an authorized driver which shall be covered under the Assigned Risk Plan, provided that authorized driver has a valid driver's license and submits a Traffic Court Clearance.
