1. Delivery Instructions for Foreign Insurers (excluding those with NAICS Code 524130 – Reinsurance Carriers, i.e. with no General Agent in Guam):

All filings must be made by the insurer's local General Agent in behalf of the Foreign Insurer. The filings and the corresponding filing fees must be hand delivered by the General Agent to the Guam Department of Insurance. Please do not mail filings nor fees directly to the Guam Department of Insurance. Mailed filings and fees should be directed to the Foreign Insurer's local General Agent.

2. *Due Date: If the due date falls on a weekend or holiday, the deadline is extended to the next business day.
