Approval of Minutes

Old Business

- a. Preliminary Cost Impact Assessment for Proposed Rules & Regulations
 - Chairperson Williams sent a request to Lester Carlson (BBMR) for agency support in preparation of the assessment, which they will assist. At BBMR's request, CCB must provide the following agency costs: costs associated with a full functioning laboratory or testing facility, additional staff requirement, classification of personnel, proper training costs, workspace requirement, workstations, estimated volume of applicants from various stages of production, any indirect costs associated with implementation enforcement of the rules.
 - DRT, DOAG and DPHSS will provide their economic cost impacts by Friday, October 16, 2020.
 - Director Cruz: The Department of Agriculture will have paper copies of proposed rules and regulations and copies of the cost impact assessment in the Director's Office for the public to view. Copies will be made available via email upon request.

c. Seed to Sale RFP

- Zita Pangelinan (DPHSS): RFP had been submitted to the Attorney General for review on March 20th. In July it was returned to DPHSS requesting more information, stating that DPHSS didn't fulfill the requirements. DPHSS resubmitted on September 2nd and is awaiting reply from the AG's. Follow ups were attempted, with no feedback on the second revision. DPHSS will continue to follow up.
 - Ms. Pangelinan will send a copy to Vice Chair Shimizu at DRT.

New Business

- Annual Summit
 - Vice Chair Shimizu: CCB's regulatory agencies, along with Department of Land Management (DLM), government stakeholders and private sectors are required by law to hold an annual summit to discuss the regulation of cannabis on Guam. Due to COVID restrictions, a virtual summit will be held via Zoom. DRT will reach out to DLM, government stakeholders and private sectors to request for participation. DRT will coordinate and schedule the annual summit.
