### Announces Limited Walk-In Services Available at Agana Satellite Office

**From Monday July 6 to Friday July 10, 2020 for Driver's Licenses Which Expired March 31, 2020 and Prior; Barrigada Office Open on Saturday, July 11, 2020 for Driver's License Branch Only for Driver's Licenses Which Expired Between April 1 – April 15, 2020**

Barrigada, GU – The Guam Department of Revenue and Taxation (DRT) today announced the following regarding its Driver's License Branch services:

#### **Agana Satellite Office –**

1. Limited Walk-In Services as follows:
  - a. Monday, July 6 – Friday, July 10, 2020 from 9 a.m. to 4 p.m. for those Driver's Licenses and Guam I.D.s which expired March 31, 2020 and prior.
2. By Appointment – schedule appointments at [www.guamtax.com](http://www.guamtax.com)

#### **Barrigada Main Office – Walk-In Services as follows:**

1. Saturday, July 11, 2020 7 a.m. to 4 p.m.
  - a. For those Driver's Licenses and Guam I.D.s which expired between April 1 – April 15, 2020
  - b. For picking up permits, scheduling operating chauffer's and motorcycle written exam

Guam residents should be aware that for those Driver's Licenses and Guam I.D.s which expired from March 14, 2020 through August 31, 2020, all late fees will be waived as long as renewal is done by September 4, 2020. In addition to the waiver of late fees for these licenses, Guam DRT has also given an automatic extension for those licenses through August 31, 2020 as long as renewal is done by September 4, 2020.

Guam DRT will be announcing additional walk-in schedule for Driver's Licenses at a later date. **Customers are reminded that Driver's Licenses cannot be renewed in advance of 90 days of expiration. Only Driver's License Branch will be open on Saturday, July 11, 2020.**
